News Highlights

- A cyclonic circulation over northeast Assam may bring scattered rainfall or snowfall with thunderstorms from Feb 13-15. Arunachal Pradesh could see isolated heavy rain on Feb 13, while light rain is expected in Assam, Meghalaya, Nagaland, Manipur, Mizoram, and Tripura.
- Southern Indian states are experiencing rising temperatures, with maximum day temperatures expected to increase over the next 8-10 days. West Maharashtra, Madhya Maharashtra, parts of Tamil Nadu, and Kerala's coast are set to see soaring temperatures.
- With imports becoming more expensive and increased purchases by dal mills, prices of tur, urad, and masoor saw a rise in the domestic market. Meanwhile, the prices of moong and chana remained almost stable in the producing markets.
- The rise in demand from dal mills has led to an increase in urad prices. In Chennai, the prices of urad imported from Burma have also surged. Experts suggest that the increase in urad prices in Burma has weakened sales in the domestic market.
- Increased purchases by dal mills have led to a rise in arhar prices. In Chennai, the price of lemon arhar has surged in dollar terms. Traders say that prices of lemon arhar have increased in Myanmar, which has reduced sales by importers in the domestic market. As a result, a slight improvement in prices is possible, but a significant rise is not expected at this time. Arrivals of desi arhar remain steady in key producing states like Karnataka and Maharashtra.
- Limited purchases by dal mills have led to stable chana prices in Delhi during the evening session. Experts say
 that while prices rose initially following the news of the central government halting duty-free imports of
 yellow peas, millers are now purchasing based on their immediate needs, considering the upcoming new
 crop.
- Turkey's winter lentil crop is approaching a critical two-week period, according to Mehmet Sonmez of Armada Foods. Adequate rainfall will be key to determining yields, as conditions have been quite dry so far. Current forecasts indicate rain in Sanliurfa and Gaziantep today, with some snow in Gaziantep. Additional showers are expected only on February 18th and 20th.
- In Argentina, high temperatures and a lack of rain are challenging upcoming bean seedings in Tucumán, according to the Agricultural Producers and Cattle Farmers Association. Pulses, especially beans, are the most vulnerable, and farmers are urged to wait out the heatwave and reassess conditions in 10 days. While rain is forecasted this week, concerns remain high as seedings cannot progress without sufficient moisture. Temperatures in Tucumán and Córdoba could reach up to 44°C.
- In Mexico, recent frosts in Sinaloa have damaged chickpea and bean crops, potentially affecting both quality and yield, reports Debate. Agustín Espinoza Lagunas of COUC highlighted concerns over the impact on production.
