News Highlights

- Widespread light to moderate rain with isolated heavy to very heavy showers is likely over parts of East, Central, West and South India during 24–30 September. Thunderstorms with gusty winds (30–50 kmph) are expected in several regions including Vidarbha, Chhattisgarh, Odisha, Coastal Andhra Pradesh and Telangana. Northeast India will also see scattered rain with isolated heavy falls on select days.
- Burma Urad Vessel Arrival Update: Vessel M.V. OCEAN BLOSSOM V04 carrying 8,000 MT of Urad from Myanmar arrived at Chennai port on September 21, 2025, according to shipping agency reports.
- Canada Yellow Peas Vessel Arrival Update: Vessel M.V. SANTA EMILIA carrying 72,188.014 MT of Yellow Peas (Matar) from Canada is expected to arrive at Mundra port on October 17, 2025, according to shipping agency reports.
- NAFED released the results of its auction held on 22 September 2025. In this auction, Chana from Gujarat (R-23 season) fetched a price of ₹5101 per quintal, Moong from Rajasthan (K-24 season) ranged between ₹6675—₹6712 per quintal, and Masoor from Madhya Pradesh (R-25 season) recorded a price of ₹6851 per quintal.
- The Maharashtra government has announced a ₹1,339-crore relief package for farmers whose crops were damaged by heavy rains between June and August 2025. The package will benefit 1.92 million farmers across 1.54 million hectares, based on damage assessments completed so far. Officials said losses from ongoing rains in Marathwada are still being evaluated. Relief and Rehabilitation Minister Makarand Jadhav-Patil stated that the immediate assistance aims to ease farmers' distress and help them restart agricultural activities.
- Chickpea harvest is underway in Queensland and will begin in about four weeks in New South Wales
 Australia, with most growers expecting average to above-average yields. Good winter rainfall has
 supported crop development, and a gentle finish is expected for southern Qld—northern NSW crops with
 peak harvest in late October—mid-November.
- South Australian and Victorian Lentil crops are generally healthy but lack subsoil moisture, so yields will fall without rain in the next fortnight. New-crop prices have dropped to \$590-\$600/MT delivered port, at least \$100/MT below last month, as Canada supplies the Middle East and South Asia. Eyre and Yorke Peninsula growers have forward sold since May, but Victorian growers are more hesitant and may store crops to sell on price spikes
- Australia Weather: Heavy rain hit Queensland's North Tropical Coast with 15–100 mm (over 100 mm in some areas), while troughs brought 10–50 mm to parts of NT, Qld and NSW. Southern Australia saw 10–25 mm widely and up to 150 mm in western and central Tasmania, with the week's highest total 556 mm at Topaz Alert, Qld.
