News Highlights

- The Southwest monsoon has fully withdrawn from the entire Northeast region, including all eight states, on October 14 — the same date as last year, according to the IMD. With its retreat, dry northwesterly winds are sweeping across the region, marking the transition to a cooler, drier spell and the onset of the winter season
- India's retail inflation cooled to 1.54% in September 2025, the lowest in over eight years, down from 2.07% in August, according to government data. The sharp fall was led by easing food and beverage prices, even as inflation in miscellaneous items like gold and silver rose. This marks the second instance in 2025 when inflation has remained below 2%, continuing the year's disinflationary trend.
- Vessel M.V. LIEFDE from Canada, carrying 71,500 MT of pulses (including lentils and yellow peas), is scheduled to arrive at Hazira Port on October 15, 2025, as per shipping agency reports.
- The government is closely monitoring cheaper imports of pulses amid concerns that they depress domestic prices and discourage local cultivation. With Prime Minister Modi's new mission to boost lentil production and end imports by 2030, ministries are coordinating to review import duties and balance consumer inflation with farmers' returns. Despite policy efforts, the total summer-sown area under pulses has remained stagnant at around 12 million hectares this year.
- Australia Weather Cold fronts and low-pressure troughs brought widespread showers and storms, including some severe, across Tasmania and southern parts of mainland Australia. Weekly rainfall totals ranged from 10–100mm, reaching up to 200mm in parts of Tasmania and Victoria. Northern regions, including the Kimberley, Cape York, and the Top End, also saw scattered storms, with the highest weekly rainfall at 182mm in Mount Read, Tasmania, and a daily peak of 95mm at Old Delamere, NT.
- Lentil cultivation in Australia is expanding steadily, with the crop poised to surpass its previous production record from the largestever planting of 1.14 million hectares. Record sowings have been reported in South Australia, Victoria, and New South Wales, while Western Australia is rebuilding its area with the introduction of the
