Daily Pulses Report 28thOctober 2025

News Highlights

- Cloudy skies and light rain returned to Uttar Pradesh on Monday as Cyclone *Montha* over the Bay of Bengal and a low-pressure system over the Arabian Sea influenced regional weather. The IMD has forecast rain with thunder in parts of the state, while temperatures may drop by 3–4°C over the next few days.
- India's 2025–26 Rabi pulses sowing has risen by 2.74% to 0.44 million hectares as of October 24, 2025, compared with the same period last year. The increase is mainly led by Urad (+133%), Other Pulses (+61.5%), and Chana (+10.4%), while acreage under Masoor (-29%), Field Pea (-28%), and Kulthi (-46%) has declined.
- Rajasthan's Rabi pulses sowing for the 2025–26 season has increased by 15.5% to 0.74 million hectares
 as of October 27, 2025, compared with 0.64 million hectares last year. The rise is driven by higher acreage
 under chana (+15.4%) and other pulses (+37.4%), supported by favourable soil moisture and early field
 preparations.
- India's moong exports surged over fourfold to 55,201 MT during Jan–Aug 2025, up from 13,383 MT a year ago. The sharp rise was driven by strong demand from China, which imported 34,816 MT, along with higher shipments to Nepal, the USA, the UK, and Vietnam.
- India's chana exports rose sharply by 84% to 95,264 MT during Jan—Aug 2025, up from 51,743 MT in the same period last year. The surge was mainly driven by higher demand from the UAE and Bangladesh, which together accounted for the bulk of exports.
- Between October 10 and 22, 2025, a total of 46,150 MT of pulses arrived at Chennai Port through 1,846 containers. Major shipments included Tur from Burma (16,725 MT), Brazil Urad (11,025 MT), and Burma Urad (8,275 MT), along with smaller quantities of Mozambique Tur, Tanzania Tur, and Masoor from Russia and Australia.
- The Centre has approved procurement of moong, urad, tur, and soybean worth over ₹15,000 crore in Telangana, Odisha, Maharashtra, and Madhya Pradesh under PSS and PM-AASHA. While physical procurement will occur in three states, Madhya Pradesh farmers will receive the price difference directly in their bank accounts.
- Australia Weather: Widespread rain and storms affected interior and southern Australia during the week
 as low-pressure systems and cold fronts moved across the region. Rainfall totals ranged from 15–100
 mm, with higher falls up to 125 mm across Tasmania, Victoria, New South Wales, South Australia, and
 parts of Western and Northern Australia. Central and south-eastern Queensland also saw 10–50 mm of
 rain, with Mount Baw Baw (Victoria) recording the highest weekly total of 124 mm.
