News Highlights

- Cyclone *Montha* has cweakened into a cyclonic storm over coastal Andhra Pradesh, with the death toll rising to two, according to the IMD. The system is expected to retain its current strength for the next few hours, bringing heavy rain to parts of Bengal, Odisha, Telangana, Jharkhand, and Madhya Pradesh.
- Gujarat Chief Minister Bhupendra Patel has ordered a seven-day survey to assess crop losses caused by unseasonal rains that affected over 10 lakh hectares across the state. According to Agriculture Minister Jitu Vaghani, 239 talukas in 33 districts received rain between October 23 and 28. Both technological and physical surveys will be conducted to ensure all affected farmers are covered.
- India has decided to end duty-free imports of yellow peas to support domestic pulse growers. Starting November 1, imports will attract a 10% duty and a 20% Agricultural Infrastructure Development Cess (AIDC), making the total levy 30%, according to a Finance Ministry notification. Consignments shipped before October 31 will remain duty-free. The move comes amid peak kharif arrivals and aims to boost farmer returns, as tur, urad, and moong are currently trading below their MSPs.
- The Ministry of Agriculture and Farmers Welfare (MoAFW) has approved the procurement of pulses and oilseeds worth ₹15,095.83 crore for the Kharif 2025–26 season under the Price Support Scheme (PSS). The move aims to ensure remunerative prices for farmers and stabilize market rates during the peak arrival period.
- Lemon Tur prices stayed stable in Chennai and Myanmar. Weak miller buying caused slight softness, but limited stockist selling may support prices. Demand is expected to rise with the November wedding season, though a major uptrend is unlikely.
- Chana Sowing is progressing well in Karnataka, though rains have delayed or prompted re-sowing in parts of Maharashtra, Madhya Pradesh, and southern states. In Rajasthan, rainfall may disrupt sowing, with some farmers shifting focus to wheat cultivation. Overall progress remains satisfactory despite weather challenges.
- Global Weather Weather: Rain has returned to France, where much of the growing region has received 130–140% of normal rainfall since early July. Ukraine and Russia are also seeing more showers, while rainfall across Victoria and South Australia is proving beneficial.
- US-China Summit: Presidents Trump and Xi Jinping met in Busan for the first time since 2019, discussing trade, tariffs, and fentanyl control. Trump announced a one-year trade deal, cutting tariffs to 10%, while China's COFCO bought 180,000 MTof U.S. soybeans, boosting hopes of easing trade tensions.
- Indonesia is seeking to negotiate a 0% tariff on its key agri exports to the US, aligning with the tariff concessions recently granted to Malaysia. The discussions aim to secure equal market access for Indonesian products such as palm oil, rubber, and cocoa, which currently face a 19% import duty. Officials say achieving parity with Malaysia would enhance Indonesia's export competitiveness in the US market.
