News Highlights

- *The IMD has issued rain and cold wave alerts across several parts of the country. While Tamil Nadu, Kerala and the Andaman & Nicobar Islands may receive rainfall with gusty winds, north and central India—including Delhi, Haryana, Uttar Pradesh, Bihar, Jharkhand, Punjab, Rajasthan and Madhya Pradesh—are likely to face intense cold wave and dense fog conditions. Snowfall is expected in higher reaches of Uttarakhand and Himachal Pradesh, with extremely low temperatures forecast in hill stations such as Manali and Shimla.*
- *Nafed will launch its own e-auction portal, Nafex.in, on January 19 to sell pulses and oilseeds procured under the PSS and PSF, reducing reliance on private platforms such as mjunction and NeML. The portal, developed with Deloitte, may also be opened to state cooperatives, offering an alternative to private platforms that currently charge buyers a 0.03% transaction fee.*
- *NCCF and Nafed have begun direct procurement of pulses—tur, urad, masoor and chana—from pre-registered farmers at MSP in APMC mandis to ensure remunerative prices and reduce import dependence. The move, supported by waiver of mandi levies and expanded under PM-AASHA and PSS, aims to protect farmers from price volatility, boost pulse production, and build buffer stocks through wider, faster MSP purchases across key states.*
- *Australia Vessel Update: The vessel M.V. GLORIA DEL MARE, carrying a total of 37,192.71 MT of pulses from Australia—comprising 24,083.44 MT of chana (chickpeas) and 13,109.27 MT of masoor (lentils)—is scheduled to arrive at Kandla Port on January 16, 2026, as per shipping agency reports.*
- *Australia's chana imports into India have reached 3,69,294.92 MT so far, with major arrivals recorded at Kandla, Mundra, and Deendayal ports. Key vessels such as MV Sea Eagle, MV Brooks, MV VBS Pollux, and M.V. Gloria Del Mare contributed significantly to volumes between November 2025 and mid-January 2026, reflecting steady import inflows amid strong domestic demand.*
- *Australia's chickpea and lentil shipments surged in November, with chickpea exports rising to 0.38 million MT, up sharply from 97,622 MT in October, driven mainly by demand from Pakistan, Bangladesh and Sri Lanka. Lentil shipments also jumped to 0.27 million MT from 45,311 MT a month earlier, led by strong buying from Bangladesh, the UAE and Pakistan.*
